

Telega EDI and Microsoft Dynamics™ NAV

Electronic Data Interchange (EDI) refers to computer to computer exchange of business documents in electronic format, for example, sales orders and invoices as e-documents.

Benefits of EDI orders and invoices

- **TIME** – increased speed of processing orders and invoices
- **ACCURACY** – less costly errors as human mistakes are eliminated
- **SECURITY** – documents are delivered over secure channels to authorized recipients
- **COST EFFICIENCY** – no double-entry of data, much smaller processing costs
- **FASTER SUPPLY CYCLE** – products get to stores faster, invoices get paid faster



What is Telega EDI Module?

Telega EDI Module in MS Dynamics NAV 2015 software enables to exchange e-documents with all companies in Telega EDI network.

MS Dynamics NAV 2015 Estonian version supports the exchange of following EDI documents:

- ✓ receiving sales order (ORDER)
- ✓ sending despatch advices (DESADV)
- ✓ receiving receive advices (RECADV)
- ✓ sending sales invoice (INVOICE)

How much does EDI cost?

Fees to Microsoft:

Telega EDI Module licence fee € 1 500 + 16% BREP or € 65 monthly in licence rental model.

Fees to Aptus Group:

- Activating Telega EDI Module in standard software costs up to € 1 500 (3 working days).
- For more advanced purchase-sales processes activation please contact Aptus Group specialists.

Fees to Telega:

- From Aptus Group users of MS Dynamics NAV 2015 software Telega **will not charge EDI setup fees**.
- Fee for document exchange consists of monthly fees and per document fees. There are 3 price packages available starting from € 9 monthly.

How to start with EDI?

In case your company uses MS Dynamics Navision 2015 Estonian version you need to make 3 simple steps for to start using EDI benefits and Exchange e-documents with more than 4000 companies in Baltic States:

1. First, please contact Aptus Group OÜ (www.aptus.ee) MS Dynamics NAV specialists at +372 51 77 644 or aptus@aptus.ee. Note that only customers with MS BREP (The Business Ready Enhancement Plan) can purchase Telega EDI Module licence.
2. Second, you need to join Telega EDI network. For that, please write to Telega sales representatives at telega@telega.com or call +372 651 0650. After signing the contract, an account will be created for you in Telega EDI system and links for your trade partners. This can be done **within 1 working day**.
3. Third, you need to modify your agreements with your trade partners to specify Telega EDI as channel for communication and exchange of EDI orders and EDI invoices.
