## Burwash CEP School's Pupil Premium Grant, its use and impact – 2017/18

Pupil Premium is a government grant which is allocated to schools based on the number of children eligible for free school meals and the number of looked after children. Schools are entitled to spend their allocated Pupil Premium Grant (PPG) in a way that they think will best support the raising of the attainment and achievement for these children.

At Burwash we are determined to give every child access to high quality teaching to enable them to reach their potential. For teachers to be able to give the most attention to the children in their care, we also believe that a high quality teaching assistant in every class is also essential. This combination of high quality teaching through a partnership in the classroom, has led to above National results for well over ten years at Burwash; a trend we wish to continue. Cuts in the school budget have meant that it is increasingly difficult to be able to guarantee a teacher and a teaching assistant (TA) in every class, so with this in mind we have committed to spend a large proportion of our pupil premium funding to ensure that this successful partnership can continue to the benefit of all children in the school.

Additionally the PPG is used to remove any barriers to learning which may exist; such barriers may include specific special educational needs, the ability to access and pay for extra opportunities such as trips or music lessons, emotional difficulties, the ability to pay for healthy food such as milk. We feel it is important that all pupils should be able to take part in all experiences that the school offers, regardless of their home circumstances. With this in mind some PPG is used to subsidise residential trips and other experiences (see breakdown below).No child is ever excluded from any experience because they cannot pay and the PPG helps to ensure we can afford to continue this philosophy.

In the financial year (April-April) 2015/16 the school was allocated £25,380 and in 2016/17 the school was allocated £19,060 each pupil who is currently eligible (or has been eligible in the last 6 years) for free school meals (FSM) is allocated £1320. Looked after children are each allocated £1900. At Burwash there tend to be a few children in every year group who attract the PPG.

For the Year 2017/18, the sum allocated is £30,200. The money we have been allocated will be used to provide for the following:

The money continues to be well spent and is having a sustained impact on attainment and achievement. The impact of pupil premium is considered formally through the monitoring of assessment data. It is also considered during pupil progress meetings that take place three times a year. End of KS2 data for 2017 is shown below:

The pupils attracting PPG in 2017 did exceptionally well with every child attaining Reading, Writing and Maths at the expected level or higher. This score is well above National and East Sussex attainment both for children attracting PPG and children not attracting PPG. However we are well aware that with small numbers such data should be viewed with caution.

The attainment of pupils entitled to PPG funding was well above National PPG data and in line with data relating to all children nationally. However all PPG data at Burwash is based on very small numbers of children which means it should be viewed with caution as it is not statistically viable.

If your child does not have FSM but may be eligible because of your family's income level, please contact the office (in confidence) to register them. Even if you do not wish them to have the meals, this would mean the school could still claim Pupil Premium funding that would be used to help your child. In addition to this children in KS1 who receive FSM whatever their circumstances can still be eligible for pupil premium funding.

Please note: No child is singled out for receiving PPG and the children are totally unaware of who receives this additional funding.
