Financials were presented by Charlie Heaven. Reviewed September financials and Nov. 1 cash position – high net position in cash. Budget on track.

Director's Report – Updated Board on corrective action plans, as overseen by "Turnaround Office" – goal to increase scores by 2%. Will be at BCCS in Feb. for site visit, April meeting with accountability office – standard follow-up from charter renewal.

 McDonald's ribbon cutting ceremony 11/21 at 10am. BCCS received \$1000 donation, Board members encouraged to attend if able.

Laura Calligan discussed efforts in increasing visibility of BCCS → engage in community and identify potential collaborations (ie. Mattatuck Museum, Chamber of Commerce).

NECSN updates – BCCS to be highlighted in video educating legislatures on charters

Katie Parente and Lily Zhao updated Board on first round of DRA/IReady testing.

- IReady students below level meeting with interventionist, each cycle 10wks and then retested; Deans checking in with teacher every 5wks. 20-30% 2+ below,
- DRA based on 2017-18 scores, students placed in guided reading groups aligned with level/focus of instruction, reassessed over past month. Each teacher is now qualified as a guided reading teacher.

In response to inquiry on using BCCS space for community event; Board discussed public use of space for events not hosted by school.

Motion to approve only sponsored events with outside organization which is hosted by BCCS; no outside groups or public use of space - Jeanine Pocoski; 2nd Cathy Smith. Approved unanimously
