When processing personal data, we are guided by applicable personal data protection legislation, including Regulation (EU) 2016/679 of the European Parliament and of the Council (GDPR) and the Personal Data Protection Act.

Rights of the data subject:

You are entitled to:

- Get to know your personal information
- Personal data correction
- Personal data erasure
- Personal data transfer
- Withdraw consent
- Decline a decision merely based on automated processing

Legal basis

The EDC processes personal information derived from the company's daily activities based on a legitimate interest in providing products or services that are relevant to you, and either assist or complement existing solutions.

EDC can process data:

- To complement marketing activities, personalize and measure results
- To personalize and enhance the user experience on the website
- To answer different inquiries
- To create promotional material such as invitations, reminders and newsletters

If the EDC provides a service to you or your company, then the processing of personal data and therefore the sharing of personal data with us will also take place.

We process customer data for the preparation of contracts, proposals, and implementation. Subsequently, we process personal information, which includes the names, contact details, and posts of the company representatives.

If there is no contract, we will only store the personal data for statistical purposes for a limited period of time. The EDC has a legitimate interest in sending marketing communications to its partners and customers in order to maintain a business relationship with them.

To maintain sales contacts, we use a client management system that ensures data security. Access to the database is restricted to the employees of the company.

How do I opt out of receiving a newsletter?

To *unsubscribe* from newsletters, click unsubscribe in the newsletter footer button. Once you have given up our newsletter, no more will be sent. You can always sign up for the newsletter again.

COOKIES ON THE DISAINIKESKUS.EE WEBSITE

Like most websites, we also use text files called “cookies” to help us develop our service.

By continuing to use our website, you consent to the use of cookies as described herein, unless you altered your web browser’s setting to block cookies.

What are cookies?

A cookie is a small text file that your web browser saves on your computer and lets the website remember user preferences.

The cookies we use:

- Cookies that are necessary for our website to function. These include, for example, cookies that allow you to make a price request.
- Analytics cookies that allow us to recognize and count visitors and see how they are using the site. This will help us improve the performance of our website, for example, by helping users find what they are looking for easily.
- Cookies that help us recognize you when you return to our website. With them, we can personalize your content and remember your preferences, for example, your language or region.
