## 1. Name and contact details of the person responsible and representatives

#### 2. Contact data of the data protection officer

The appointment of a data protection officer in accordance with the GDPR is not mandatory.

## 3. Purposes and legal basis of the processing

Photos of members and events will be published on the association's website www.friendsofWMIS.de for the purpose of public presentation. The legal basis for this is Art. 6 para. lit a) GDPR. Print media and digital media (association newsletters, posters for events or projects) which are sent to the members' e-mail addresses or published on the association's website are created for the purpose of self-advertising by the "Förderverein 2. SISB". The legal basis for this is Art. 6 Para. lit. f) GDPR.

#### 4. Justified interests of the association

The "Förderverein 2. SISB e.V." has a legitimate interest in processing personal data known to the association for the purpose of checking the existence of a declaration of consent. A publication of photos for the purpose of self-promotion only takes place after consent.

## 5. Recipient of personal data

The association does not transmit personal data (photos) of its members to third parties. In the case of publication on the association's website, the data is publicly visible to website visitors (members / non-members) even from countries without a comparable data protection law.

# 6. Transfer to third countries

There is no provision for the transfer of photos to a third country.

#### 7. Retention period

In case of revocation of consent, the data will be deleted immediately.

#### 8. Rights of the persons concerned

Any member of the association as a data subject has the right to request access to (Art. 15 GDPR) and rectification (Art. 16 GDPR) or erasure of personal data ('right to be forgotten') (Art. 17 GDPR) or restriction of processing concerning the data subject (Art. 18 GDPR) or to object to processing (Art. 21 GDPR) as well as the right to data portability (Art. 20 GDPR).

A member of the association has the right to revoke their declaration of consent under data protection law at any time. The revocation of consent shall not affect the legality of the processing carried out on the basis of the consent until revocation. Furthermore, a member of the association has the right of appeal to a data protection supervisory authority.

#### 9. Obligation to provide the data

There is no obligation to consent to the publication of photos.
