Summary

Building note is an official document approved by local government (in case of Ülgase by Jõelähtme Municipality) through EHR - National Building Register (www.ehr.ee). Approvement of it does show that all needed documents are there, coordination with needed stakeholders is done and building can be done during next three years. In case of Ülgase, building note did contain all data on fence measures, coordinates of fencing site locations, information about landowners and had attached construction drawing (sketch) of the fence; terms of reference from RMK (who is practical manager of nature conservation on one of the land parcels, Knuudi, in Ülgase), including scheme of fence locations; approvement letter by one of the private landowners and contract between other landowner, Estonian Fund for Nature and Environment Board on fence building; coordination letter from Environmental Board (who is responsible manager of nature conservation in Ülgase).

Building note for fencing in Ülgase contains data about applicant – ELF and its contact person, project manager Lauri Klein; main documents attached (construction drawing, fence location schemes and building description); technical details of the building heights (absolute 3,6 m and actual 1,53-1,73 m) and length (350 m) and basement of the building; list of land parcels concerned and coordinates of turning points of the fence.
