**Content summary and list of documents for fencing in Vääna-Posti
project site**

Summary

Building note is an official document approved by local government (in case of Vääna-Posti by Saue Municipality) through EHR - National Building Register (www.ehr.ee). Approval of it does show that all needed documents are there, coordination with needed stakeholders is done and building can be done during next three years. In case of Vääna-Posti, building note did contain all data on fence measures, coordinates of fencing site locations, information about landowners and had attached construction drawing (sketch) of the fence; coordination with four private landowners; coordination letter from MKA (who is responsible of national heritage site in Vääna-Posti); coordination letter from KEA (who is responsible manager of nature conservation in Vääna-Posti).

Building note for fencing in Vääna-Posti contains data about applicant – ELF and its contact person, project manager Lauri Klein; main documents attached (construction drawing by OÜ Suurmeister, fence location schemes by ELF and building description by builder OÜ Suurmeister); technical details of the building heights (absolute 3,23 m and actual 2,23 m) and length (160 m) and basement of the building; list of land parcels concerned and coordinates of turning points of the fence.
