### OVERVIEW

This website is operated by e-resident store OÜ. ##### Legal address- and Authorized Contact Person services

Upon the expiry of this agreement you are no longer authorized to keep our company registered as Authorized Contact Person of your entity.

Legal address and authorized contact person services are sold for 12 month period, beginning from the following day of your purchase and ending the previous date next year.

You are entitled to one legal address and one authorized contact person service per agreement.

You are responsible to amend the legal address and/or authorized contact person in the business registry and to ensure your business partners shall not send their post to the provided postal address from the day of changed details of the address or termination of this agreement at the latest.

If you have not amended the legal address and/or authorized contact person of your entity in the business registry within one (1) month from the expiry of this agreement, you will then be liable for contractual penalty in the sum of 200 (two hundred) euros. We reserve the right to appeal business registry for deletion of incorrect details from the register. You shall be liable for all expenses occurred in relation to appeal and amendment of the legal address of your entity upon expiry of this agreement.

##### Accounting- and Tax Services

If you have signed up with any of our service plans for accounting- and tax services, you are entitled for monthly recurring service.

We undertake to provide your entity with accounting- and tax services based on the service plan you have chosen, in accordance to the legislation of the Republic of Estonia. Note, that we are not liable for meeting tax reporting- or other deadlines stipulated in the laws, if you have failed to supply us with documentation in agreed time.

If from time to time the characteristics of your entity change and it no longer fits into limits of selected service plan, you will then be upgraded into higher service plan where it fits.

In order for us being able to provide you with tax services, you undertake to register our accountants and other staff as required, at the tax- and business authorities on behalf of your entity.

#### Recurring services and recurring payments
