# Professional Higher Education Admission Rules for the 2026/2027 Academic Year

## 1. General Provisions

- 1.1. The Estonian Aviation Academy (EAVA, hereinafter also "Academy") Admission Rules regulate the admission of student candidates (hereinafter "applicant") to the professional higher education study programmes in the 2025/2026 academic year.
- 1.2. Admission is organised by the admission board approved by the Rector's directive.
- 1.3. The number of students admitted per study programme is established by the Council of the Academy based on the Minister of Education and Research directive on the allocation of activity support, and the training needs and resources of the Academy.
- 1.4. Admission is based on a ranking list formed on the basis of points scored at the admission competition. The maximum number of competition points is 100. For the results of national examinations and each entrance examination, the maximum number of competition points is assigned.
- 1.5. To apply for a study place at the Academy, an applicant must:
  - 1.5.1. have secondary education or equivalent foreign qualifications;
  - 1.5.2. submit an admission application within the prescribed time limit;
  - 1.5.3. submit supplementary documents if required to certify compliance with admission requirements;
  - 1.5.4. meet the language proficiency requirements;
  - 1.5.5. meet the admission requirements (described in annexes to these rules).
- 1.6. An applicant must be able to pass a background check. When submitting an application, the applicant confirms that there are no circumstances with regard to them that impede passing the background check described in § 46<sup>9</sup> of the Republic of Estonia Aviation Act.
- 1.7. All issues not regulated in these rules are resolved by the admission board.
- 1.8. Any amendments and supplements to the admission rules may be made by the EAVA Council.

### 2. Submission of documents

2.1. Within the period specified in the admission timeframe, applicants applying for Estonian-taught curricula submit an application through the Study Admission Information System (SAIS), and for English-taught curricula through the admission system for international students (DreamApply).

- 2.2. An applicant may submit an application for up to two competitions of Estonian-taught curricula and up to two competitions of English-taught curricula. An applicant can accept an admission offer for only one study programme.
- 2.3. All documents submitted are to be in Estonian or English. To the documents that are not in Estonian or English, an applicant adds, where necessary, a translation into Estonian or English certified by the issuing institution, a sworn translator, or notary.
- 2.4. A document certifying secondary education issued in a foreign state must be supplemented by the evaluation of the Estonian ENIC/NARIC.
- 2.5. When necessary, an applicant submits a document certifying the change of name, or a certified copy of such document.
- 2.6. For the purpose of meeting the admission requirements, the Academy converts, where necessary, the scores of the mathematics examination taken in a foreign state, the IB (International Baccalaureate) and EB (European Baccalaureate) mathematics examinations.
- 2.7. Applicants applying to Estonian-taught curricula have to prove their proficiency in Estonian at least at level B2. Level B2 proficiency in Estonian is proven by:
  - 2.7.1. basic, secondary, vocational or higher education acquired in Estonian;
  - 2.7.2. a certificate of Estonian language proficiency at level B2 or C1, or the result of the national examination in Estonian as a second language at least at level B2;
  - 2.7.3. the result of the final exam in the Estonian language within the International Baccalaureate Diploma Programme (IB) or the European Baccalaureate programme of the upper secondary cycle of the European School (EB).
- 2.8. The Admissions Committee may also consider the results of an Estonian language B2 level test taken within the admission process of Estonian higher education institutions.
- 2.9. If an applicant has submitted false and/or outdated personal or contact details, the admission board is not responsible for the provision of information.

### 3. Entrance examinations

- 3.1. Entrance examinations are:
  - 3.1.1. **an interview** a conversation with the board members on topics listed in clause 3.2. The interview may be conducted in English;
  - 3.1.2. **professional aptitude tests** online personality questionnaires for assessing the suitability of a person, personal data form, and written aptitude tests;
  - 3.1.3. **theoretical tests** online tests for assessing the applicant's knowledge and skills in mathematics, physics, logics, and using spreadsheet software (MS Excel);
  - 3.1.4. **First European Air Traffic Controller Selection Test (FEAST)** an English-language webbased aptitude test consisting of two parts (FEAST I and FEAST II);
  - 3.1.5. medical fitness examination applicants for the Aircraft Piloting and Air Traffic Services

study programmes undergo the health checks described in § 24¹ of the Republic of Estonia <u>Aviation Act.</u>

- 3.2. **The interview** covers the following topics:
  - 3.2.1. knowledge related to the speciality chosen;
  - 3.2.2. organisation and content of academic speciality studies;
  - 3.2.3. correspondence of the applicant's motivation with the aims and requirements of the study programme;
  - 3.2.4. prior learning and work experience;
  - 3.2.5. analysing postulated situations and solving tasks.
- 3.3. Entrance examinations can be taken within the timeframes specified in the annexes.
- 3.4. Applicants applying for more than one study programme pass the entrance examinations required for respective programmes within the timeframes described in the annexes.
- 3.5. The admission board has a right to exclude from the subsequent competition any applicants who have not followed the timeframes described in the annexes.
- 3.6. The admission board has a right to exclude from the entrance examinations any applicants who fail to abide by the organisation of work.
- 3.7. Each applicant may take entrance examinations only **once per calendar year.** The FEAST tests can be taken only one time and if the applicant applies again the following year(s), the result achieved earlier is taken into account.
- 3.8. The threshold is the minimum score received for compliance with the admission requirements of the curriculum ensuring that the applicant can continue the competition.

#### 4. Filling student places

- 4.1. The Academy admits applicants who meet all the admission requirements of the respective curriculum and whose place in the ranking list is within the number of student places.
- 4.2. The Academy informs admitted applicants of the decision on admission within the timeframes specified in the annexes.
- 4.3. Admitted applicants are required to accept or reject the offer of admission through SAIS or DreamApply or by sending an email to <a href="mailto:vastuvott@eava.ee">vastuvott@eava.ee</a> within the timeframes specified in the annexes.
- 4.4. Failure to notify within the given period is considered a renouncement of the student place. In this case, the vacant student place is offered to the next applicant in the ranking list.
- 4.5. When submitting applications to the Academy, the applicants indicate whether they wish to study part-time or full-time, except for the study programmes where only full-time study is possible.
- 4.6. Students who, without valid reasons, fail to appear for the studies within two weeks after the start of studies and have not confirmed their declaration of subjects in the Study Information System are deleted from the matriculation register. The vacant student place may be offered to the next applicant in the ranking list of the same year.

- 4.7. Applicants who do not agree with the results of the admission competition may submit a written appeal to the chair of the admission board within 3 (three) working days after announcing the contested decision. The chair along with the members of the admission board resolve the appeal at the earliest opportunity, but not later than within 5 (five) working days, and the reply to the appeal is communicated to the applicant.
- 4.8. The Academy may revoke the decision on admission to the Academy if it becomes apparent that the applicant's prior education does not enable them access to studies at the desired level of higher education or the applicant has submitted forged documents or false information.
- 4.9. The Academy is not liable for any possible patrimonial or non-patrimonial damage that may arise from the revocation of the admission decision.
- 4.10. The details of the applicants are automatically archived by SAIS when two months have passed from the due date for performing the applicant's operations.
- 4.11. Based on the decision of the admission board, the applicant is matriculated by the Rector's directive on 22 August 2026 at latest.

## Annex 7. English language proficiency exemptions

The English language proficiency requirement may be waived if an applicant meets one of the following criteria:

- 1. has acquired secondary education in English in one of the following countries: any of the U/EEA member states, UK, USA, Canada, Australia, or New Zealand. If the applicant has studied in an offshore campus of any of the above countries, a recognised English proficiency certificate is still required;
- 2. has studied in English (with English as medium of instruction) in full-time student status for at least one academic year at a higher education institution in one of the following countries: UK, USA, Canada, Australia, New Zealand, or any of the EU/EEA member states. The transcript of records must include information that the applicant was enrolled in the programme taught in English. If the applicant has studied in an offshore campus of any of the above countries, a recognised English proficiency certificate is still required;
- 3. has completed the International Baccalaureate Diploma Programme (IB DP) or European Baccalaureate (EB) Diploma Programme in English;
- 4. holds a Cambridge general certificate of education (GCE or IGCSE).
