

Establishment of tuition fees for the 2025/2026 academic year

Based on clause 16 (8) of the Higher Education Act, clause 14 (17) of the Statutes of the Estonian Aviation Academy (hereinafter the Academy), and 1.2 of the Estonian Aviation Academy's Conditions and procedure of reimbursement of the tuition fees (hereinafter ÕKH), the study costs shall be established as follows:

1. Tuition fees¹ for the full-time student in Estonian-taught curricula, who does not complete the curriculum in full (ÕKH (1.5.1) and for the student studying in Estonian-taught curricula who interrupts their studies after 70 calendar days from the beginning of the semester (ÕKH (1.5.6) 40 EUR/ECTS, flight training for the Aircraft Piloting curriculum 120 EUR/ECTS;
2. Tuition fees² for the student who recommences studies (ÕKH (1.5.4, 1.5.7, 1.5.8, 1.5.9 or 1.5.10), for the part-time student in Estonian-taught curricula (ÕKH p. 1.5.2), or for the student studying in a curriculum in which the language of instruction is a foreign language (ÕKH (1.5.5) are as follows:
