ANNEX 1 Manual "Urban open spaces for all" (working title)

Aim

This manual is targeted for professionals in the field of spatial planning, such as experts in urban planning, landscape architects, architects and also NGOs working with people with disabilities first of all of cities in the North-West of Russia. Furthermore it applies to experts dealing with the assessment of public space accessibility.

The manual should ensure that the mentioned stakeholders and target groups communicate with each other, provoke the participation of the general public and all necessary planning steps will be made transparent by combining them logically.

The task includes:

- Identifying relevant stakeholders and target group and their needs
- Describing categories of open spaces
- Categorizing connected affordances of these open spaces
- Information about EU, Russian legislation and standards used while planning of open spaces;
- Describing the planning of different elements in open spaces, giving good or bad examples (with explanations) and paying special attention to the geographical location of target cities and present realities of economic situation
- Bringing examples of best world's practices in the development and maintenance of accessible urban green areas

Structure

The manual structures scales of different open spaces and connected actions. The specific target groups of the study have certain needs, which in a perfect way can be matched by affordances of a category of public spaces.

- <u>Target group examples:</u> people with movement, visual, hearing etc. disorders
- <u>Needs examples:</u> to move safely in a space, to overcome gradients in open spaces, to get orientation without visible elements, etc.
- <u>Categories of open spaces:</u> large areal public spaces, mid-size urban open spaces etc.

- <u>Connected</u> affordances examples: paved paths of sufficient width, Wide range of resting / sitting elements, Safe traffic crossing possibilities
- <u>Planning different elements in open spaces</u>: Ramps, railings, benches and other elements of small size architecture; materials to be used dependent on the necessity of target groups, etc.

For the preparation of the Manual it is recommended to use not only literature on the topic, but practical experience, the "Friendly Cities" Project materials and results (if available), previous partners' studies, lessons learned and experts' reports.

Lengths: 30-40 pages (A4), including references and excluding annexes Manual should contain also graphs, tables, photos.

Language: Manual language in Russian, with English summary (3-5 pages)
