## What's new?

### Our second anniversary on September 23rd

We celebrated two years of working together to bring awareness and diversity into this field. It has been two years of challenges and achievements and we could not be happier to share it with you!



### Mentorship Programme

We launched the call for our Women4Cyber Mentorship Pilot Programme during the summer. The mentorship aims to help women improve their skills and advance their cybersecurity careers at all levels. Mentors provide personal and professional guidance, share their experience, and help mentees identify and achieve career goals. Applications for the W4C Pilot mentorship programme closed on 30 September and the matching is underway.

The programme will officially launch in late October 2021, and other mentorship programmes with industry partners are foreseen in the future.



## Training Programmes

Two contests were run in Summer 2021 to offer free passes for a few lucky Women4Cyber community members to participate in training programmes offered by two of our partners:

- **'Cyber Security Awareness & Culture Manager'** training programme: two members of the Women4Cyber community will participate in the training programme organised by the Cyber Security Coalition (Belgium).



- **Training programme on Cloud Certification:** two members of the Women4Cyber community participated in the training organised by the EU A4CEF project partners, NSAI (Ireland), Digital Security Authority (Cyprus), Red Alert Labs (France) and Kypriaki Eteria Pistopoiisis Ltd (Cyprus).

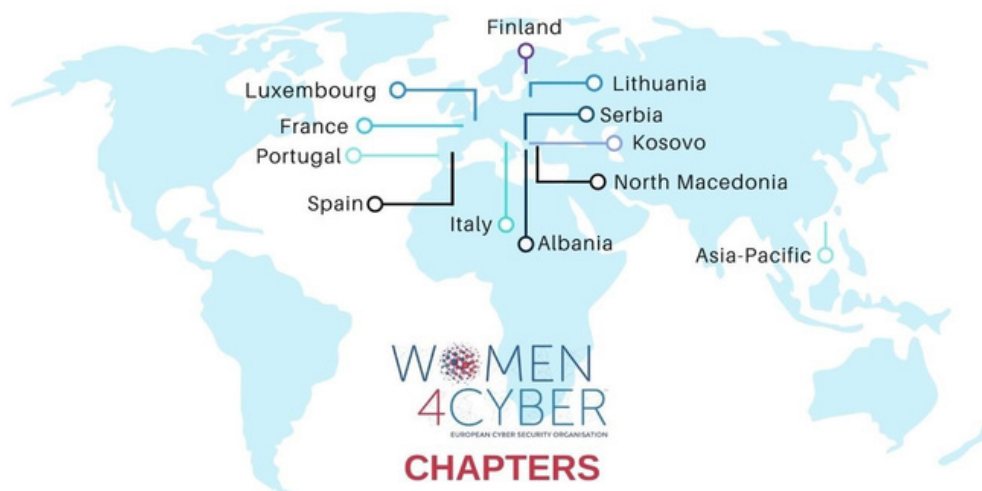
## BeNeLux Summit Event

## News from our chapters



### Women4Cyber Spain

This October marks the first anniversary of the launch of Women4Cyber Spain, The W4C Spain association, initially just a board of 15 leading female professionals in the security and the Information and Communications Technology (ICT) industries chaired by Eduvigis Ortiz, has now grown to ten regular collaborators and more than 80 associates.

W4C Spain organises regular meetings with different female professionals, all of the leaders in their respective fields of action. The last one was on October 6 about "Mobility, Cybersecurity and Digital Transformation", having as main guest Esther Mateo Rodríguez, D.G. Security, Processes and Corporate Systems at ADIF.

### Women4Cyber Albania

Women4Cyber Albania is implementing the #Huawei4HER initiative, supported by Huawei. This initiative aims to reduce skills and gender gaps in Albania by presenting cybersecurity as a possible and desirable career option. Its mission is to engage role models of the ICT industry in Albania and connect them to talented students through featuring monthly mentoring circles, inspirational master classes, and further improve the cyber impact. Also, within this initiative, a training module was organized dedicated to "Cyber Hygiene" with the presence of representatives of the Municipality of Tirana and the Education System. Masterclasses will follow to build the capacity of the business sector in relation to raising awareness on cyber risks.

### Women4Cyber Lithuania

In July 2021 Women4Cyber Lithuania organized Cyber Picnics, where members discussed the current status of women involvement in cyber and IT in Lithuania and set the roadmap for the chapter activities. The Chapter also started a partnership with the "Sunset Digital Innovations Center".

In September, the Chapter started a communication campaign, presenting its members on social media via articles on different cyber security topics. Before the launch of this activity, the Chapter organised an internal training on communication for the members of the Chapter.

Women4Cyber Lithuania was a partner of the annual ESET Cyber security conference where two members took part as speakers in the panel discussions.



Women4Cyber Lithuania together with the British Embassy in Vilnius will organise an event on the 26th of October where experts from government, industry and academia will explore different approaches to supporting and promoting women's participation in cyber and tech.

### Women4Cyber Luxembourg

On September 29th, the EU institutions, bodies and agencies (EUIBAs) got together to kick-off virtually the European Cybersecurity Month. The event was co-hosted by the ECA and the European Commission.

Bringing together key cybersecurity experts from the EU institutions and their peers in Luxembourg society, the two institutions prepared a programme that included a spotlight on Women in Cyber. Vice President of Women Cyber Force, Krystina Gray, joined the women-only panel that highlighted the important role of women in reinforcing the cybersecurity stance of EU organisations and helping to fill the current skills gap in the field. ### Women4Cyber Serbia

AFA organizes the fifth Women's Leadership Summit (WLS), which will take place on 21st October 2021 in a virtual environment. The Summit is AFA's annual regional flagship event, originally established in 2017 with the idea to connect, empower, support and elevate women leaders from different fields. The Summit also aims at gathering women together to address globally urgent topics and participate in the creation of a more innovative and sustainable economic and societal solutions.

The central topic of this year's summit is "Future of women at workplace". One panel session titled "Gender and Talent Gap - Cyber Security Missing Women Leaders" will be dedicated to women in cyber security and will seek the participation of W4C Serbia Vice President, Sanja Kekić, and other women in cyber security. Having more women would help boost the industry and fill in the huge need that companies have for top talent. W4C Serbia invites all of you to register as an audience and join a day of networking, inspiration and action.

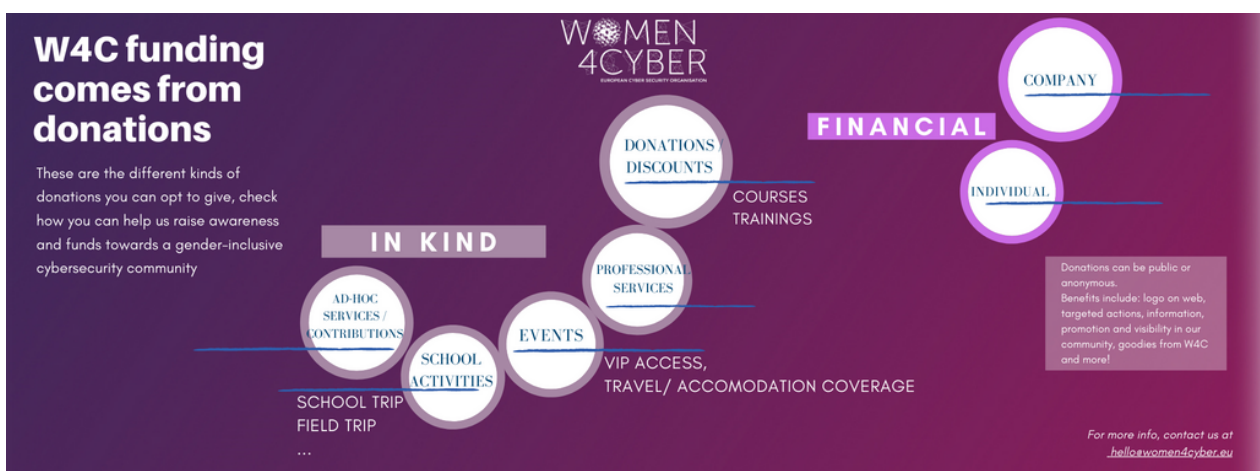

On 7 October, the European Parliament adopted the report "State of EU cyber defense capabilities", which stresses that a common cyber defense policy and EU cooperation on cyber capabilities are key issues for the development of a European Defense Union. The Parliament also recommended setting a Joint Cyber Unit for improved information within the EU. MEPs also warned that the EU must become more technologically independent, innovating and investing more in cyber defense capabilities and personnel.
