9:20–11:00 Defining the political agenda of the Three Seas Initiative

Since its inception in 2015, the Three Seas Initiative has set the agenda, emphasising economic growth, investment, energy security, digitalisation, climate change, and geopolitics. Is there a need to revise or prioritise the priorities identified? In which areas is immediate investment needed to strengthen and develop not only the 3SI region but Europe as a whole? Europe's democratic tradition calls for the involvement of civil society in decision making. What is the role of the 3SI in civil society? To what extent can European civil society benefit from the 3SI? The 3SI is already attractive to both the region's neighbours and other partner countries. What will be the role and place of a wider partnership with countries outside the region?

Connectivity

Digitalization
