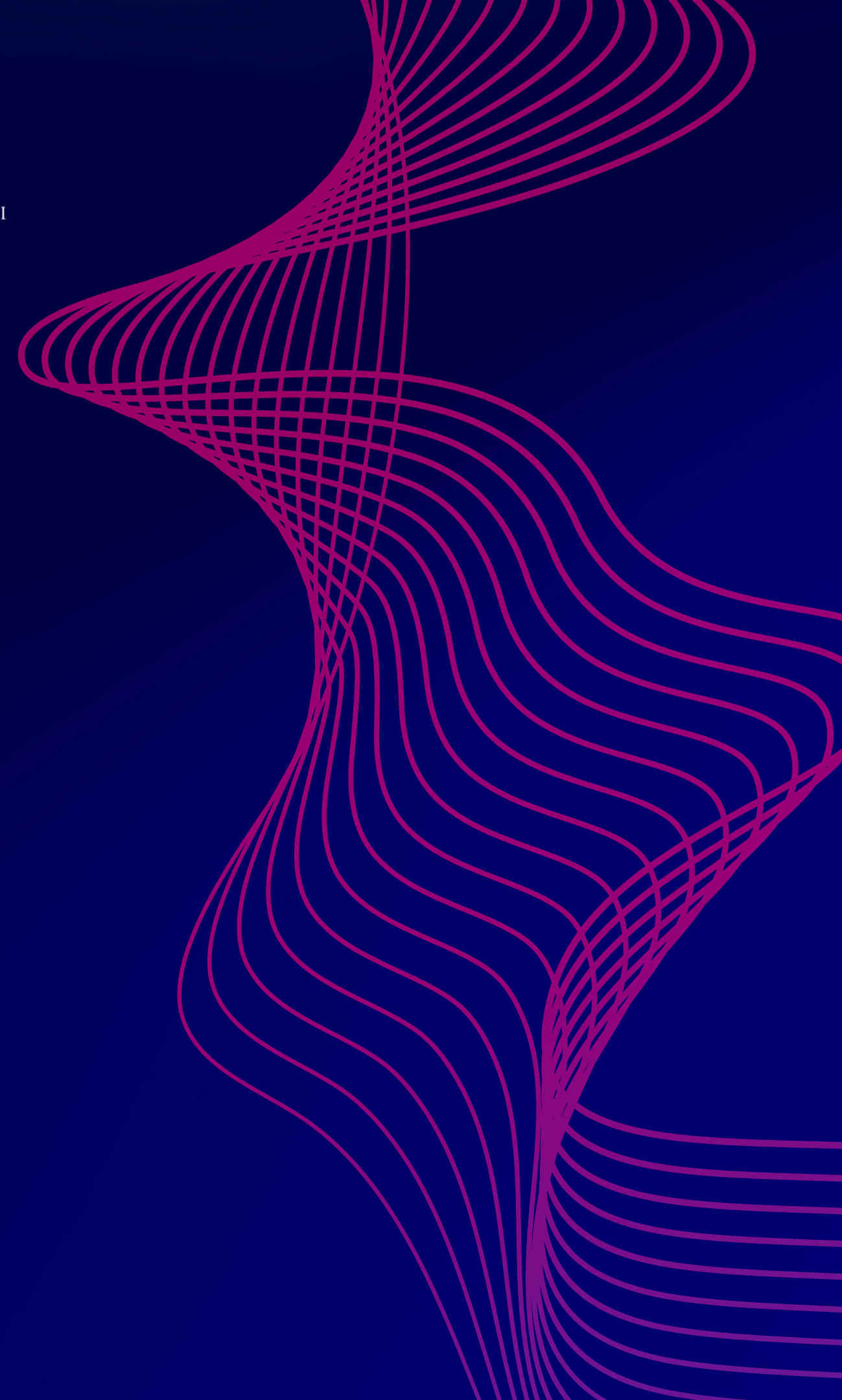

# Cyber Security for Operational Resilience in the Context of the Cloud Paradigm

Romania has a cyber security and defense law, initiated by the Ministry of Research, Innovation and Digitalization (MCID), with the support and consultation of all public and private entities with attributions in the field of cybersecurity.

The absolute novelty is that MCID will develop a multi-year program for financing research, development and innovation projects in the field of cyber security, in which public and private research organizations, as well as public authorities and institutions with attributions in the field of cybersecurity, can participate.



# Cyber Security for Operational Resilience in the Context of the Cloud Paradigm

Romania launched on May 9th, 2023, in Bucharest, the activity of the The European Cybersecurity Competence Centre - in the field of industrial, technological and cyber security research (ECCC).

The reconfirmation of the solid contribution that Romania brings to the development of the European projects and to the increase of the resilience of the Union, in a period marked by major security challenges, including in the field of cyber security.

# Cyber Security for Operational Resilience in the Context of the Cloud Paradigm

MCID signed bilateral documents to strengthen mutual efforts to detect, prevent, eliminate the effects of cyber attacks and improve cooperation in responding to cyber security incidents.

- Memorandum of Understanding on cooperation in the field of cyber security between the National Directorate of Cyber Security in Romania and the Council for Cyber Security in the United Arab Emirates.

We have the largest investment under way through NRRP - the Governmental Cloud - approximately 561,000,000 Euros without VAT and agreements signed with the European Investment Bank and the World Bank.
