# What are Climate Friendly in Procurements?

## The Procurement that Never Happened:

- Always consider the Necessity of each Procurement
- Look for Alternatives Within existing organisation
- Look for possibilities of Cooperation

## The Procurement that is Fit for Circularity:

- Consider the Life Cycle Cost, including possibilities of second Life
- Choose products that can be Reintroduced to Circle with as High Value as possible
- Choose Materials that has a Low Cost for Reuse or Redesign as possible
- Choose Materials that has a Low Need for Energy in a Recycling Process

# What are climate friendly in Procurements?

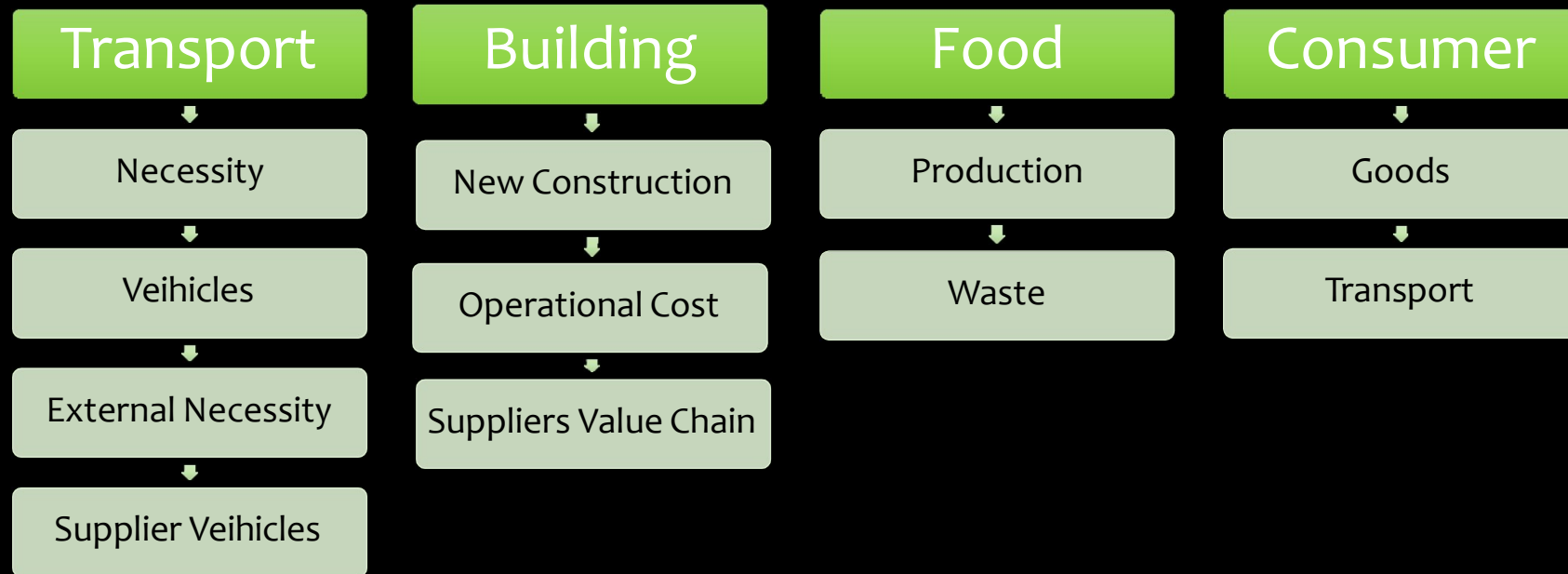
## The Procurement that Contributes to Reduction of CO<sub>2</sub>e Emissions:

- The Procurement that Reduces Emissions Directly compared to Existing Product, Service, or Solution
- The Procurement that Reduces Emissions Indirectly through reduced Activities

## The Procurement that can be Shared:

- Map out Your Real Motivation for a Procurement, Real Numbers
- Participate in Communities for transfer of Competence and Knowledge

## All Areas:

- Be Creative look for Cooperation
- Demand Zero or Low Emission as a Rule, Exemptions must be Justified
- Find the Net Cost and Gains
- Involve the User
- Communicate Strategy to Suppliers (!)
- Include the Purchaser on climate basis Early, Support Systemshave Application Time
- Allow your suppliers to «overdeliver» on Climate Friendly Solutions, Offer Up Bonuses
