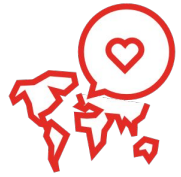


# Partner countries (25%)

- Reponse by the COM





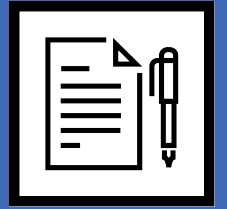
„The current “budget approach” would be retained, so the whole budget of the project would be considered as contributing to cooperation with third countries not associated to the Programme“



- Each NA would be invited to announce in advance for each call in their website the indicative amount to be made available for projects involving third countries not associated to the Programme.
- **25% threshold as a maximum**, but NAs that have many projects with partners from non-programme countries would then be **able to ask the Commission (desk officer) to authorise exceptionally an increase** of this maximum ceiling when duly justified.
- The forecasted expenses would then be monitored by the Commission, and if the approach would lead to trespassing the overall 25% ceiling for KA1, a **new approach would need to be explored**.

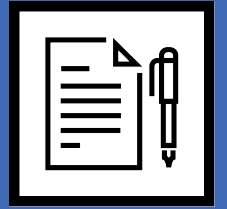
