

# Communication on achieving the EEA by 2025

Announced the upcoming proposal for a Council Recommendation on learning mobility as a key building bloc of the EEA

Announced the development of a policy framework on teacher mobility as part of the proposal

External dimension: the EEA should contribute to the geopolitical goals of the European Union



# Key Council Resolutions

On a strategic framework for European cooperation in education and training towards the EEA and beyond (2021-2030) of 18 February 2021:


- Second of 5 strategic priorities: **Making lifelong learning and mobility a reality for all**

On the European Education Area: looking to 2025 and beyond of 16 May 2023:

- **Identifying and removing obstacles to learning mobility while encouraging inclusive, sustainable and balanced mobility is key to the full achievement of the EEA**

# Proposed EU-level targets by 2030

At least 25% of higher education graduates

At least 15% of vocational education and training learners

At least 20% people with fewer opportunities out of all learners benefiting from learning mobility



# Twelve recommendations to Member States (1-6)

1. Provide systemic learning mobility opportunities
2. Enhance language learning
3. Support engagement in learning mobility activities
4. Provide information on learning mobility opportunities
5. Support transparency and recognition of learning outcomes
6. Support transition to labour market and work mobility



# Twelve recommendations to Member States (7-12)

**7. Make learning mobility more inclusive and accessible**

**8. Make learning mobility more environmentally sustainable**

**9. Make use of digital technologies to facilitate learning mobility**

**10. Promote EU values through learning mobility**

**11. Promote the EU as a learning destination**

**12. Support the implementation of the Recommendation**



# Annex 1: Policy framework for teacher mobility

## Set of actions proposed at school, local, regional and system level


- Integrating mobility into the initial education and professional development of teachers
- Improving cooperation at local level by developing and implementing a strategic approach towards teacher mobility
  - Embedding teacher mobility in the overall development of schools
  - Allocating the necessary resources
- Promoting the benefits of learning mobility and supporting it with the necessary training



# Annex 2: Policy framework for apprentice mobility

**Member States recommended to put in place framework including:**

- System level requirements for facilitating apprentice mobility
- Support for apprentices
- Support for companies
