








European Solidarity Corps, total budget for all participating countries, 2018-2027


Erasmus+ distribution of the total amount of host organisations for each subfield in of all participating countries, 2022

























ESC – PARTICIPANTS - ALL COUNTRIES



ESC – ACCREDITION - ALL COUNTRIES





STATEMENT 5

National Authorities require more current and detailed data on both programs from the EC to develop evidence-based and knowledge-based policies effectively.



- Erasmus + dashboard: figures available in March 2024: years 2014-2020
- Erasmus+ annual reports and country reports 2021 and 2022: limited number of data
- European Solidarity Corps: data up-to-date, however only available via Portal, with limited search options.
- European Solidarity Corps: one multi-annual report 2018-2019
