

SUPPORT FOR THE NETWORK OF YOUTH NAs

At the BM in Paris, the Network agreed on the proposal of the Co-group for support the network of Youth NAs in its work and increase the effectiveness of our work (see annex). After the BM in Prague, we will start the implementation of the decision. Please find below the proposal and intended construction, especially for hiring two freelancers to support the network.

1. Support for meetings of the Co-Group and BMs

- Support for prep, organisation and follow up of BMs

- Total: 24.200€ / year

- Work is coordinated by that NA in coordination with the co-group
- During October BM: Report of activities, including the working hours according to time sheets (max. approved hours)
- During October BM: Proposal for the next year
- Invoice: For the first year: NA sends invoice in June for 2023
- Further invoicing: in December for the next year (so Dec. '23 -> '24)

Proposal development process per tool

- The coordinator will search for at least three offers for supporting companies
- The coordinator presents the selection of the companies to the co-group (co-group decides)
- The coordinator develops together with the selected company a proposal for a concept and presents the proposal to the BM (first tool in April if feasible)
- In case of the website: the coordinator develops together with the company a proposal for the design and present this proposal to the network (during BM or video conference).
