| TECHNICAL REGULATIONS | The competitions will be held according to the FIG competition regulations and the requirements approved by the Sports Acrobatics Committee in Estonia. Pairs and groups: <ul style="list-style-type: none">• PRE-YOUTH 11 -16 (born 2015-2010), balance and dynamic routine• YOUTH (12-18) (born 2014-2008), balance, dynamic and combined routine• JUNIOR 13-19 (born 2013-2007), balance, dynamic and combined routine• SENIOR 15+ (born until 2011), balance, dynamic and combined routine Youth & Junior rules Code of Points Each athlete can take part in one discipline and category. |
| AWARDING | Qualifications and Finals in all categories. <u>Qualifications:</u> 1 Balance and 1 Dynamic routine. <u>Finals:</u> 1. 1-12 units - best 6 in the finals 2. 12 and more units - best 8 in the finals If there are fewer than 3 participants, the competition organizer has the right to combine different age groups and categories. |
| ENTRY FEE | Entry fee 55€ per competitor. The participation fee must be paid based on the invoice sent by the MTÜ Eksperimentaalse Liikumise Keskus. If the participation fee is not received at least 5 days before the start of the competition, the gymnast is allowed to compete only upon payment of 1.5 times the participation fee, either via bank transfer (upon submission of the payment order) or in cash on-site.
