TECHNICAL REGULATIONS	<p>The competitions will be held according to the FIG competition regulations and the requirements approved by the Sports Acrobatics Committee in Estonia.</p> <p>Pairs and groups</p> <ul style="list-style-type: none">• GRADE 1 (7-11) (born 2018-2014), combined routine• GRADE 2 (7-12) (born 2018-2013), combined routine• GRADE 3 (8-14) (born 2017-2011), combined routine• GRADE 4 (8-15) (born 2007-2010), combined routine• ASPIRE (former youth) 9-16 (born 2016-2009), combined routine• PRE-YOUTH 11 -16 (born 2014-2009), balance and dynamic routine• YOUTH 12-18 (born 2013-2007), balance and dynamic routine• JUNIOR 13-19 (born 2012-2006), balance and dynamic routine• SENIOR 15+ (born until 2010), balance and dynamic routine• NATIONAL SENIORS (One of the partners of the pair/group of must be at least 16) only combined routine <p>NDP 10 (Grade 1-4) FIG Age Group Rules (Youth-Seniors)</p> <p>Each athlete can take part in one discipline and category.</p>
AWARDING	<p>Ranking is based on the points obtained for the performance of one combined routine in all categories (from Grade 3 to ASPIRE and NATIONAL SENIORS).</p> <p>In PRE-YOUTH, YOUTH, JUNIOR (11-16, 12-18 and 13-19) and SENIORS the ranking is formed by summing the points of the two routines.</p>

ENTRY FEE	<p>30€ Grade 1-4 per competitor. 35 € Aspire and Seniors + per competitor. 40€ PRE- Youth, Youth, Junior and Seniors 15+ per competitor.</p> <p>The participation fee must be paid based on the invoice sent by the MTÜ Eksperimentaalse Liikumise Keskus.</p> <p>If the participation fee is not received at least 5 days before the start of the competition, the gymnast is allowed to compete only upon payment of 1.5 times the participation fee, either via bank transfer (upon submission of the payment order) or in cash on-site.</p> <p>Withdrawal from participation by a registered competitor:</p> <p>Until 09.05.2025 – 100% exemption from the participation fee From 10.05.2025 – the entry fee will not be refunded.</p>						
JUDGES	<p>Nomination of Judges 09.05.2025</p> <p>Each club must insure at least one category 1 or 2 national or international category judge for every five pairs or groups. Registered judges will be present until the end of the award ceremony. There will be a 150€ penalty fee if no judge is present.</p>

TARIFF SHEETS AND MUSICS	<p>Tariff sheets and music must be through the Rgform database.</p> <p>Musics and tariff sheets should be identified as follows: CATEGORY_AGEGROUP_FAMILYNAME_FAMILYNAME_CLUB/COUNTRY</p>						

	<p>Example: WP_Grade3_KASK_LEPP_AK/EST</p> <p>A double entry fee will be charged for late registrations (including late tariff sheets or music).</p> <p>Changes to the tariff sheets can be made on-site up to 4 hours before the competition. The club coach is required to bring 4 copies of the modified tariff sheets.</p>
<p>FINANCIAL CONDITIONS AND INSURANCE</p>	<p>Each delegation bears the cost of travel, accommodation and meals.</p> <p>Organizers do not take any responsibility in case of any accidents at the time of your stay in Estonia. Therefore, we highly recommend everyone to take care of their insurance policy. First aid is provided.</p>
<p>TIME SCHEDULE</p>	<p>The exact schedule will be announced 3 days before the start of the competitions and will be published on the website of Akrobaatika Kool, https://omatsirkus.ee/et and sent to the participants by email.</p>
<p>ADDITIONAL INFORMATION</p>	<p>The personal data of gymnasts, coaches, judges and volunteers registered for the competition will be used in publishing the competition results in the competition protocol, in the rgform.eu environment, on the website of the sports association and / or organizer and on social media channels.</p> <p>When registering for the competition, gymnasts, coaches, judges, and volunteers automatically give permission to publish visual materials (photos, videos). If a person does not agree with the display of his/her personal data and visual materials, the main organizer of the competition and the federation must be notified in writing by the beginning of the competition at the latest.</p> <p>The organizer reserves the right to make changes to the competition organization if necessary and will inform participants of any changes that may affect them</p>
