AS Natural juhindub puitmaterjali varumisel, tootmisel ja vahendamisel FSC ja kontrollitud puidu tarneahela standarditest ning hea metsandustava printsiipidest ja teeb oma ettevõttes kõik endast oleneva, et vältida alljärgneva puidu kasutamist ja vahendamist:

- Illegaalselt raiutud puit;
